## APPLE AMBASSADOR APPLICATION GUIDELINES

2021

A student will be selected as the North Carolina Apple Ambassador to represent the North Carolina Apple Festival and the North Carolina Apple Growers Association. The North Carolina Apple Ambassador shall also be the recipient of the Evelyn Lutz Hill Memorial Scholarship. The term of the Apple Ambassador shall be for one year after selection.

THE AMBASSADOR WILL REPRESENT THE NORTH CAROLINA APPLE FESTIVAL AND THE NORTH CAROLINA GROWERS ASSOCIATION AT THE FOLLOWING EVENTS. THE FOLLOWING ARE **MANDATORY** APPEARANCES.

1. The 2021 NC Apple Festival – Labor Day Weekend. You will be expected to attend **ALL** events that are feasible. You will ride on the North Carolina Apple Growers Float in the King Apple Parade on Labor Day.
2. To appear with a governmental official to declare September apple month for the State of North Carolina.
3. Mountain State Fair – Opening Ceremony – September, 2021
4. North Carolina Apple Growers Meeting – January 2022
5. Any other event that schedules permit to represent and promote the North Carolina Apple Festival and the North Carolina Apple Growers Association.

TO BE ELIGIBLE THE APPLICANT MUST:

1. Be a rising senior in High School in Henderson County, North Carolina;
2. Mail a **COMPLETE** application form and attachments to the North Carolina Apple Festival Office by the date specified. The mailing address is Post Office Box 886, Hendersonville, NC 28793.

THE SELECTION CRITERIA WILL BE BASED ON:

1. A complete application received at the North Carolina Apple Festival Office by the deadline specifications.
2. Final Applicants will be notified by letter of their selection for interview with the committee who will select the Apple Ambassador.
3. The Committee will meet with the final applicants in an interview and the final applicants will also be asked to **give a short speech demonstrating the applicant's ability to communicate knowledge of the apple industry and the festival.**

THE WINNING APPLICANT WILL RECEIVE: (AFTER ALL DUTIES ARE FUFILLED)

1. The Evelyn Lutz Hill Memorial Scholarship in the amount of \$2,000.00 to the college of their choice.
2. A gold apple charm designed by Rudi of The Goldsmith.

THE FIRST RUNNER-UP WILL RECEIVE: (AFTER VOLUNTEERING AT THE APPLE FESTIVAL)

The Evelyn Lutz Hill Memorial Scholarship in the amount of \$1,000.00 to the college of their choice.

If selected as a semi-finalist onto the Ambassador Court, your attendance is REQUIRED to volunteer at the NC Apple Festival AND ride in the King Apple Parade.
